

HelloInsiders Sweepstakes Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: HelloInsiders Sweepstakes (the "Sweepstakes") is open only to legal residents of the fifty (50) United States (and the District of Columbia) and Canada (excluding Quebec), who are at least eighteen (18) years old at the time of entry. Employees of HelloWorld, Inc., and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Sweepstakes is subject to all applicable federal, state, provincial, municipal, territorial and local laws and regulations and is void in Quebec and where prohibited by law. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor/Administrator's decisions, which are final and binding in all matters related to the Sweepstakes. Timing: The Sweepstakes begins July 1, 2017 at 12:00 a.m. Eastern Time ("ET"), ends December 31, 2017 at 11:59 p.m. ET ("Promotion Period"), and consists of six (6) monthly entry periods (each a "Monthly Entry Period"). Each Monthly Entry Period begins at the start of each calendar month and ends on the last day of each calendar month. HelloWorld's computer is the official time keeping device for this Promotion.

4. How to Enter: There are two (2) ways to enter the Sweepstakes:

- a. **Enter Online:** During the Promotion Period, visit <https://www.helloinsiders.com> and follow the links and instructions to complete and submit the registration form, including a valid email address.
- b. **Enter Through the HelloWorld Facebook Application:** During the Promotion Period, you can enter the Sweepstakes application (the "Application") on the HelloWorld Facebook brand page at <https://www.facebook.com/HelloWorldIncorporated?ref=profile>. You will advance to the Application authorization page where you will be required to authorize Sponsor/Administrator to pull your profile information and other content that the Application will require to work in order to participate in the Promotion. Then you can follow the links and instructions to complete and submit the registration form.

After completing the registration form, you will automatically receive one (1) Sweepstakes entry into the applicable Monthly Entry Period drawing.

Limit: Each participant may enter one (1) time per day during the Promotion Period. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Disputes: Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Eastern District of Michigan (Southern Division) or the appropriate Michigan State Court located in Oakland County, Michigan U.S.A.; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
